

## Notice for Hostel Admission in PGGC-11, Chandigarh

Admission in Hostels of PGGC-11 is open for the **old STUDENTS** of **UG** and **PG** classes with immediate effect. The Principal reserves the right to decide allotment of rooms to number of students according to size and space of the room as instructed in the guidelines of COVID -19.

The following conditions are required to be fulfilled by the students seeking admission;

- 1. Classes will be held in both mode-offline and online.**
2. Students seeking hostel have to pay **hostel fees** charges for full semester.
3. Submission of RT-PCR COVID test (Status – negative) is compulsory at the time of arrival in the hostel. The test report must have been done during within **72** hours of the admission to hostel.
4. Self quarantine of 14 days in the Hostel room is mandatory after the arrival.
- 5. No student will be allowed to leave the campus during his/her stay in the hostel except in medical emergency. In case of any emergency and written request from the parents, the resident can leave the hostel but on rejoining he or she will have to repeat the COVID test and submit the report again.**
6. Eligible students will be informed about the date of joining the hostel as and when the sufficient numbers of students are admitted.
- 7. All students will have to pay for mess food on monthly basis and no outside tiffin or food will be allowed inside the premises of the hostel.**
8. Symptomatic students shall not be permitted to stay in the hostels under any circumstances. They will be referred to the nearest COVID treatment facility for clinical assessment and treatment. The parents and local guardian have to make alternate arrangements for medical care of such students immediately.
9. The student will stay in his/her allotted room only. No sharing of the room will be allowed.
10. There should be no crowding in hostel areas including common room, library, computer room, dining hall, grounds/parks. The students will have to maintain physical/ social distancing and follow COVID-19 norms strictly.
11. Thermal screening of all resident students will be done every day at the time of entry and exit of Hostel.
12. All the students and their parents have to furnish an undertaking at time of joining the Hostel.
13. Students seeking hostel require to fill the Google form.
